**APPROVAL FOR PUBLIC CONSULTATION OF THE DRAFT REGULATION “ON THE  
IMPLEMENTATION OF THE GENERAL AUTHORIZATION REGIME”**

and with the participation of Secretary Ms. Xhilda Hoxha, at its meeting held on 22 December 2025, pursuant to Articles 14 and 15 of Law No. 54/2024 “On Electronic Communications in the Republic of Albania”, as amended, and the Internal Regulation on the Functioning of AKEP’s Steering Council, adopted by Decision No. 7, dated 16 February 2017, as amended, examined the matter concerning:

- “Approval for public consultation of the draft regulation ‘On the Implementation of the General Authorization Regime’”.

**LEGAL BASIS:**

1. Article 27(8) of Law No. 54/2024 “On Electronic Communications in the Republic of Albania”.
2. Regulation on “Notification and Public Consultation Procedures”, adopted by Steering Council Decision No. 21, dated 7 December 2021.

**THE STEERING COUNCIL CONSIDERS:**

Upon review of the following documentation:

1. Document for public consultation: Draft Regulation “On the Implementation of the General Authorization Regime”;
2. Reasoned draft decision;
3. Accompanying explanatory report;

and in reference to discussions held during the meeting and in support of the legal basis,

#### **WHEREAS:**

1. Law No. 54/2024 entered into force on 20 December 2024, repealing Law No. 9918/2008. This law partially transposed Directive (EU) 2018/1972 of the European Parliament and of the Council establishing the European Electronic Communications Code (EECC).
2. The draft regulation ensures the practical and harmonized implementation of Articles 12, 13, and 16, and Annex I of Directive (EU) 2018/1972, in conjunction with Articles 20, 26, 27, 29, and 30 of Law No. 54/2024, which regulate the general authorization regime for electronic communications networks and services.
3. Based on the new provisions of Law No. 54/2024, the regulation establishes:
  - The form and content of notifications;
  - Supporting documentation;
  - Confirmation of registration of the notification;taking into account recommendations from BEREC and ITU, as well as relevant provisions of other legal and sub legal acts affecting electronic communications, including:
  - Law on Territorial Planning and Development;
  - Law on Environmental Permits;
  - Law on Environmental Protection;
  - Law on Personal Data Protection;
  - Law on Consumer Protection;
  - Relevant subordinate acts;
  - AKEP regulations.
4. Pursuant to Article 27(8) and Article 191(3) of Law No. 54/2024, AKEP has prepared the draft regulation “On the Implementation of the General Authorization Regime”, which shall be subject to public consultation with interested parties.
5. In accordance with Articles 44 and 45 of Law No. 54/2024 and the Regulation on Notification and Public Consultation Procedures, adopted by the Steering Council Decision No. 21, dated 7 December 2021, the approved document shall be published for public consultation to obtain the views of stakeholders.

#### **FOR THESE REASONS:**

Pursuant to Articles 14(1) and 15(1) of Law No. 54/2024, the Steering Council of AKEP,

#### **DECIDES:**

1. To approve the publication for public consultation of the draft regulation “On the Implementation of the General Authorization Regime”, as attached;

2. The public consultation shall last forty-five (45) days from the date of publication, pursuant to point 3 of this Decision;
3. his Decision and the draft regulation shall be published on the AKEP website at [www.akep.al](http://www.akep.al).

This decision enters into force immediately.
