ON

APPROVING FOR PUBLIC CONSULTATION THE DOCUMENT: “DRAFT-REGULATION ON THE PROCEDURE AND METHOD OF CALCULATING THE ANNUAL PAYMENT LEVEL MADE TO AKEP FOR THE SUPERVISION OF THE ELECTRONIC COMMUNICATIONS MARKET AND POSTAL SERVICES”

The Steering Council (SC) of the Authority of Electronic and Postal Communications (AKEP), with the participation of:

and the Secretary, Ms. Kledja Çikopano, in the meeting dated 27.08.2025, pursuant to the procedure set forth in Law No. 54/2024 “On Electronic Communications in the Republic of Albania”, and the Internal Regulation “On the Functioning of the Steering Council of the Authority of Electronic and Postal Communications”, approved by Decision No. 7, dated 16.02.2017, of the AKEP Steering Council, as amended, reviewed the matter with the subject:

- Approval for public consultation of the document Draft-Regulation “On the procedure and method of calculating the annual payment level made to AKEP for the supervision of the electronic communications market and postal services”

LEGAL BASIS:

1. Point 1 of Article 17, point 1, letter “a” of Article 19, Articles 20 and 36 of Law No. 54/2024 “On Electronic Communications in the Republic of Albania”;
2. Articles 27 and 31 of Law No. 46/2015 “On Postal Services in the Republic of Albania”.

THE STEERING COUNCIL:

Upon reviewing the written documentation composed as follows:

1. The document for public consultation: “Draft-Regulation on the procedure and method of calculating the annual payment level made to AKEP for the supervision of the electronic communications market and postal services”;
2. The formatted and reasoned Draft Decision;
3. The accompanying Explanatory Report of the Draft Decision;

NOTES THAT:

1. Law No. 54/2024 “On Electronic Communications in the Republic of Albania”, which entered into force on 20.12.2024, repealing Law No. 9918/2008 “On electronic communications in the Republic of Albania”, as amended, defines the sources of financing, principles, and types of payments made to AKEP.
2. The Draft-Regulation has been drafted taking into account the provisions of Articles 17, 19, 20, and 36 of Law No. 54/2024, as well as Articles 27 and 31 of Law No. 46/2015 “On Postal Services in the Republic of Albania”.
3. Article 20 of Law No. 54/2024 and Article 27 of Law No. 46/2015 define the payment for the supervision of the electronic communications market and the postal services market, the calculation methods of this payment, as well as the deadlines for its payment by electronic communications operators and postal service providers.
4. Based on Articles 44 and 45 of Law No. 54/2024 and the Regulation “On notification and public consultation procedures”, approved by SC Decision No. 21, dated 07.12.2021, the document approved through this decision shall be issued for public consultation in order to obtain the opinions of interested parties.

FOR THESE REASONS:

Based on point 1 of Article 14 and point 1 of Article 15 of Law No. 54/2024 “On Electronic Communications in the Republic of Albania”, the AKEP Steering Council.

DECIDES:

1. To approve the issuance for public consultation of the document “Draft-Regulation on the procedure and method of calculating the annual payment level made to AKEP for the supervision of the electronic communications market and postal services”, according to the attached document.
2. The public consultation procedure shall be conducted over a period of 30 days from the date of publication of the document as stated in point 3 below.
3. This Decision and the document for public consultation “Draft-Regulation on the procedure and method of calculating the annual payment level made to AKEP for the supervision of the electronic communications market and postal services” shall be published on the website: www.akep.al.
4. The Directorate of Finance and Support Services is tasked with the follow-up and implementation of this decision.

This decision enters into force immediately.
